

Dear ADRC Colleague,

We wanted to take the opportunity to update the ADRC community on the status of the new UDSv4 forms, our plans for language translations, and the options that will be available for ADRCs to collect and share their UDS data.

UDSv4 Form Progress:

The Clinical Task Force (CTF) is continuing to integrate your feedback, resolve issues, and make final updates to the new UDSv4 forms. We greatly appreciate the significant amount of time and effort they have contributed towards finalizing these forms.

70% of UDSv4 form content finalized

- The CTF is drafting an additional form with questions on diseasemodifying therapies.
- Form C2 (neuropsychological battery): An optional verbal list learning test will be added (sites can choose between RAVLT and CERAD).
- **RxNorm medication ontology** will replace Multum (MMSL) for UDSv4.

UDSv4 Translations:

- The UDSv4 forms will be translated into Spanish and Chinese. NACC is currently identifying ADRC partners to assist with these translations.
- 35 ADRC sites responded to NACC's survey in January that assessed additional translation needs.

REDCap and UDSv4:

We are modernizing our data infrastructure at NACC, and a key element of this initiative is leveraging REDCap electronic data capture for UDSv4. We will not be requiring Centers to use REDCap and the new UDSv4 forms will be available in both paper and electronic (REDCap) format. However, for those who are interested in using REDCap, we have taken the following steps to assist the ADRCs.

- REDCap trainings: NACC is excited to welcome Laura McLeod, our new Senior REDCap Administrator! Laura will assist NACC with its REDCap initiatives.
- The New UDSv4 Electronic Data Capture Working Group launched
 January 24th: This group will be focused on optimizing use of REDCap for

UDSv4 by evaluating requirements, collaborating on form development, and on providing documentation and training.

- NACC is developing Best Practices and Standard Operating Procedures (SOPs) for UDSv4 and REDCap.
- Support: We'll be providing support options for you to submit your REDCap questions.
- Survey coming soon: Please look for our upcoming REDCap survey. We want your feedback on how we can support your ADRC to make the transition to REDCap a success!
