#### **CLARiTI in the News**

#### Brain scans begin for nationwide Alzheimer's disease study

CLARITI was recently featured in multiple news outlets spotlighting the invaluable contributions of our research participants, especially those from underrepresented communities. The coverage emphasized our commitment to ensuring at least 25 percent of participants come from historically underrepresented groups, a crucial step in addressing health disparities in AD/ADRD and medical research as a whole. It highlighted the important milestone of scanning our first participants for CLARITI. The initial story garnered at least 36 stories online and on broadcast and reached potential audiences of approximately 3.3 million broadcast viewers and 3.5 million online viewers.

## Exploring Alzheimer's Complexity: Research Findings on Co-Pathologies

As disease modifying therapies for amyloid proteinopathy continue to advance in clinical and research arenas, it is essential that we have an awareness of any overlapping neuropathologic change that patients and research participants may be experiencing so that treatments are better aligned with underlying pathology.

Recent research demonstrates some of the co-pathology that is present at autopsy in two papers by Woodworth et al. using NACC data (on <u>TDP-43 neruopathology</u> and on <u>LATE-NC staging</u>) and one by Corriveau-Lecavalier et al. out of the Mayo ADRC (on <u>limbic-predominant amnestic neurodegenerative syndrome</u>). TDP43-related pathology co-occurred with AD neuropathologic change (ADNC) approximately 35 percent in the NACC and Mayo datasets. In the Acta Neuropathologica article, Woodworth et al. show that ADNC co-occurred with some combination of LB and/or TDP43 approximately 65 percent of the time based on the numbers reported in their figure.

We may infer from these findings that some degree of overlapping pathology is present in some of our patients with presumed MCI or dementia due to AD. Gaining clarity on this state of affairs is one of the goals of CLARiTI and our efforts are shaped by the groundbreaking work being done in many of the ADRCs.

# CLARITI Material Transfer Agreement (MTA) Modification with NCRAD

As outlined in the <u>CLARITI Site Readiness Checklist</u>, please ensure your team prioritizes making the modifications needed to the NCRAD MTA. We recommend each site initiates this task as soon as possible, since the modification process can take several months to complete.

# Please check here to confirm if your institution has completed this modification.

This task is not on the CLARITI Study Start-up Dashboard as it will not prevent your site from being approved by CLARITI for study activation, however, your site will *not* be able to ship blood samples to NCRAD without the required NCRAD MTA Modification to include the CLARITI Appendix.

If you're currently in the process of modifying an NCRAD MTA, maintaining clear and frequent communication with your institution's MTA office and NCRAD can help expedite the process.

Following the completion of the modifications, Mica will provide sites with NCRAD updates and reminders (i.e., holiday closures that may affect ordering kits and shipping samples).

#### Shining a Spotlight on Community Research Liaisons (CRLs)

**Community Research Liaisons (CRLs)** are our "boots on the ground" for CLARITI, providing in-person engagement to the community members and organizations that make our research possible. CRLs play a crucial role in CLARITI, helping us achieve our goal of recruiting, enrolling and retaining at least 25 percent of CLARITI participants from groups traditionally underrepresented in research.

Faith Ocoko, a CRL at the Wisconsin ADRC commented, "In my role as a CRL, I hope to foster a safe and welcoming atmosphere for participants to feel as comfortable as possible. I want the process of being informed to feel easy and not overwhelming."
