NACC SESSION QUESTIONS

When can Centers submit a data request to download NACC UDS v4 data for research use?

UDSv4 Data has been collected since January 2025. Data requests that include UDSv4 data will be enabled in early 2026.

What is the approximate sample size of NACC UDSv4 so far?

As of 10/22/25 approximately 1,500 UDSv4 packets have been fully finalized and are in the dataset.

There was no mention of the new Social Determinants of Health (SDOH) module. Is the new leadership team still invested in this initiative?

Yes! The SDOH is an incredibly important and exciting new addition to the UDS. Huge thanks to the SDOH CTF Subgroup and for the strong leadership of Drs. Lisa Barnes and Megan Zuelsdorff in developing this new module. We are very excited to have the new SDOH data as part of UDSv4 and encourage all Centers to use the SDOH.

What are the plans for UDSv4 telephone follow-up/remote visits? For our participants who regularly receive virtual/phone visits, should we consider using UDSv3?

UDSv4 does not include a separate telephone packet for initial or follow-up visits. Instead, in UDSv4 the forms can be done either in-person or remotely, and you can indicate the modality in the header. Note that a packet can include a mix of modalities. For the UDSv4 neuropsych battery, you can choose either C2 (in-person or video) or C2T (telephone).

Will the new NACC website still have an “ADRC Resources” section? Progress Report information is especially helpful, as is the ADRC Program Community Forum and best practices information.

Yes, ADRC Resources will be included in the new site under the “Tools” section. We have streamlined and consolidated the information about the ADRC resources to make them more discoverable on the NACC website. We have also asked the Admin Steering Committee and NIA to ensure the Progress Report page is up to date and meets the needs of the ADRC Program.

When will the Multimodal Query Tool (MQT) be updated with data from the Fall data freeze?

We are in the process of integrating the data into the MQT. It should be available in the upcoming weeks.

What is the update on the Chinese UDSv4 translation?

The Chinese translation of the UDSv4, including cultural adaptation and scientific validation, is underway through an NIA-funded R01 led by Drs. Clara Li (Mount Sinai) and Boon Lead Tee (UCSF). We want to be respectful of their ongoing work and the scientific rigor it requires. NACC is working closely with the translation team to outline the materials that will be available and to establish an anticipated timeline for release. In parallel, we are engaging ADRCs that may use these forms with Chinese-speaking participants to gather feedback, and consulting with the NIA and the NACC Steering Committee on the utility of using forms that have not yet completed full validation. We remain committed to transparency and will continue to keep Centers informed as the Chinese UDSv4 progresses. Please watch for critical update emails from NACC.

When will the UDSv4 Milestone and NP forms be available?

The Milestones form and NP form are already available! They have not been changed, and they are available now for download on the NACC EDC Documentation site and for the first time, NACC is releasing a REDCap version of the forms as well! Starting this week, you can submit those form data through the new ADRC Portal.
