


# Project ECHO (Extension of Community Healthcare Outcomes)


- University of New Mexico in 2003
- A tele-mentoring program that combines brief didactic presentations with case-based learning
- Builds the capacity of primary care clinicians to manage common conditions
- De-monopolizes knowledge: "Move knowledge rather than patients"

### ECHO and Dementia

- About 50% of those with dementia do not have a formal diagnosis (Lang, et al., 2017; Amjad, et al., 2018)
- Thus, unable to engage in treatments to slow progression or engage in clinical research
- Clinicians express lack of confidence in diagnosing dementia (Learner, et al., 2017)
- Wait times for our specialty clinic can be as long as 6 months
- Few neurology specialists outside of PDX manage dementia




## Examples of Dementia ECHOs

#### **Alzheimer's Association:**

- One targeted towards primary care practices
- One for assisted living communities
- Both series engage multidisciplinary teams to translate the Association's principles for person-centered dementia care into tangible actions to improve practice
- University of Rochester ECHO in Geriatric Mental Health and Dementia Care (ECHO-GEMH)
  - Works with interprofessional teams involved in direct care of nursing home residents with an emphasis on care planning, non-pharmacologic management of behavioral symptoms of dementia, medication reduction and education
  - New York State Office of Mental Health requested expansion of the ECHO into the state psychiatric care system. Project ECHO-GEMH OMH will be expanding in to 60 facilities in the near future
