






NCRAD BAL: ADCFB Unique Visits with Plasma Assays Returned




Biomarker Data Available at NCRAD

- Biomarker data is returned to contributing site via NACC
- After 90-day data embargo, results are incorporated into NCRAD ADRC catalog to assist researchers in selecting samples for requests
 - Researchers requesting access to these data are vetted to check if they are for profit or not for profit investigators
- Full biomarker dataset will be available to request from NACC in future





ADRC Catalog with Biomarker Data



Two versions of catalog:

- One allows for profit and not for profit users
- Other allows <u>not</u>
 <u>for profit users</u>
 <u>only</u> based on
 GDS forms



ADRC Plasma Survey Results

- ADRC Plasma Survey sent out early 2024 to assess interest in sharing plasma collected outside the ADCFB initiative with NCRAD
 - Strong interest from many ADRCs
 - Available samples exceeded NCRAD-funded BAL capacity
- NCRAD discussed survey responses with NIA for guidance
 - Priority to samples with broadest sample sharing (i.e., GDS)
 - Anticipate running 1 sample per participant
- ADCFB plasma samples are the priority for the BAL
 - Plasma collected through ADCFB initiative have assays run automatically!

ADRC GWAS Data Update

- NCRAD has historically sent 1-2 annual shipments of DNA to CHOP for GWAS
 - Going forward, NCRAD will send samples to CHOP quarterly for more rapid data returns
- NACC, NCRAD, ADGC, and NIAGADS have been working to streamline the return of genetic data (GWAS and WGS) to the ADRCs

Count of Unique ADRC Participants with non-DNA Sample Type by Site^{1,2}


